

Glenn A. Fine is the Acting Inspector General of the Department of Defense. He has served in that position since January 2016. He joined the Department of Defense Office of Inspector General in June 2015. Fine previously served as the Inspector General of the United States Department of Justice (DOJ) from 2000 until January 2011. He was confirmed by the United States Senate on December 15, 2000. Prior to his appointment as the DOJ Inspector General, Fine served as Special Counsel to the DOJ Inspector General from January 1995 until 1996, when he was made Director of the OIG's Special Investigations and Review Unit.

Immediately prior to joining the OIG office at the Department of Justice, Fine had been in a private law practice in Washington, D.C. Before entering private practice, Fine served as an Assistant United States Attorney for the Washington, D.C. United States Attorney's Office from 1986 to 1989. In those three years, he prosecuted more than 35 criminal jury trials and handled numerous grand jury investigations.

Fine graduated magna cum laude from both Harvard College and Harvard Law School. He also obtained bachelor's and master's degrees from Oxford University where he was a Rhodes Scholar.

Myles V. Lynk is Senior Assistant Disciplinary Counsel in charge of the D.C. Bar's Office of Disciplinary Counsel ("ODC") appellate group. Before joining the ODC, he was the first Peter Kiewit Foundation Professor of Law and the Legal Profession at the Sandra Day O'Connor College of Law. Prior to teaching, he was a Partner in the Washington, D.C. office of Dewey Ballantine LLP, served as an Assistant Director on the White House Domestic Policy Staff under President Carter, and was a Special Assistant to the Secretary of Health, Education and Welfare.

Lynk served as pro bono consultant on legal ethics in the Office of the Attorney General for the District of Columbia from 2016 to 2018. In his long history with the D.C. Bar, Lynk has been president (1996–1997), a member of the Board of Governors (1993–1998), chair of the Clients' Security Fund (1989–1992), and a member of the Legal Ethics Committee (1987–1990). Lynk has also been active with the American Bar Association; he has served on the Board of Governors since 2017 and has chaired the Standing Committee on Ethics and Professional Responsibility and the Standing Committee on Professional Discipline (now Professional Regulation).

Lynk graduated cum laude from Harvard College and Harvard Law School. Following law school, he clerked for Judge Damon J. Keith of the U.S. Court of Appeals for the Sixth Circuit.

Marie L. Park is an Assistant Executive Attorney with the Office of the Executive Attorney for the D.C. Board on Professional Responsibility. In that role, she advises the nine-member Board and the several Hearing Committees in the adjudication of attorney discipline proceedings. Immediately prior to joining the Office of the Executive Attorney, Marie represented indigent criminal defendants in appeals before the U.S. Court of Appeals for the Fourth Circuit, the U.S. Court of Appeals for the D.C. Circuit, and the D.C. Court of Appeals.

Park previously worked as a legal consultant for The Alliance for Justice during the U.S. Senate Nomination Hearings for Supreme Court Justices John G. Roberts, Jr. and Samuel A. Alito, Jr. Prior to moving to the Washington Metro Area, Park was a deputy public defender in the San Francisco Public Defender's Office and a clinical instructor at U.C. Berkeley Law School.

Park received her J.D. from Harvard Law School and her undergraduate degree in Government magna cum laude from Harvard College.

Daniel I. Weiner previously served as senior counsel to Commissioner Ellen L. Weintraub at the Federal Election Commission and practiced law in the Washington, D.C. office of Jenner & Block, LLP.

He received his JD cum laude from Harvard Law School and his undergraduate degree in History magna cum laude from Brown. He clerked for the Honorable Diana E. Murphy on the United States Court of Appeals for the Eighth Circuit.
